(A) MODE OF MEETING

The 29th AGM of Favelle Favco Berhad ("**FAVCO**") will be conducted virtually through live streaming and online remote voting via Remote Participation and Voting facilities provided by Tricor Investor & Issuing House Services Sdn Bhd ("**Tricor**"). Please note that members/proxies **ARE NOT ALLOWED** to be physically present at the Broadcast Venue.

(B) REMOTE PARTICIPATION AND VOTING FACILITIES ("RPV")

- Shareholders who wish to participate in the 29th AGM may do so using the RPV facilities provided by Tricor Investor & Issuing House Services Sdn Bhd ("Tricor"). (E) POLL VOTING

The voting at the 29th AGM will be conducted by poll in accordance with Paragraph 8.29A(1) of Main Market Listing Requirements of Bursa Malaysia Securities Berhad. The Company has appointed Tricor as Poll Administrator to conduct the poll by way of electronic voting and Cooper Professional Scrutineers Sdn Bhd as Scrutineers to verify the poll results.

Shareholders may proceed to vote on the resolutions from the commencement of the 29th AGM on Tuesday, 29 June 2021, at 10.30 a.m. until the end of the voting session which will be announced by the Chairman of the meeting.

Upon completion of the voting session, the Scrutineers will verify and announce the poll results followed by the Chairman's declaration whether the resolutions are duly passed.
